- All nominees introduced themselves and discussed their backgrounds and goals
- Bill Van Sant discussed general commissioner responsibilities including communication
- Decision was made as per bylaws to vote for the Treasurer and Girls Lacrosse Co-Commissioner positions at this meeting because positions are currently vacant

#### E. <u>Baseball Move to Ripken</u>

- Deep Run is currently with Little League
- Ripken DOBs would align with travel teams
- Districts opportunity for both A and B teams
- All of Pennridge School District is in Ripken district
- Less stringent requirements than Little League
- Deep Run Baseball is asking Ripken that we keep our territory as it exists now
- Background checks would be done through Ripken
- Consensus of the board to proceed with the move to Ripken

## F. Travel Basketball Registration Fees

- Registration fees cover gym time; Cost of gym time has doubled but registration fees have remained the same
- Quakertown travel basketball fees are \$100 less
- Question of travel basketball families paying the family fee but not using Deep Run facilities
- Request that the club pay for part of the gym fees
- Motion made by Bill Van Sant and seconded by Dan Shollenberger for club to pay 25% of total travel basketball gym fees for this season; All voted yea

## A. Open Projects

- Pole Barn No update
- Connie Mack Facility Repairs Jeff Tiemann reviewed the report he prepared including various work proposals addressing holes in siding, fascia repairs due to baseball damages, electrical problems, avian excrement, installation of netting, broken window in press box, speakers, lights, etc.; Motion made by Bill Van Sant and seconded by Dan Shollenberger to approve Jeff Tiemann's Connie Mack Pressbox Restoration/Animal Prevention proposal up to \$9,326; All voted yea
- <u>Aerification/Seeding</u> Nick Gontkosky reviewed Blooming Green proposal dated 9/26/24; Will level outfield somewhat; Work to be completed after 12/2/24; Seed will need moisture; Motion made by Myles Bartos and seconded by Scott Holbert to proceed with aeration/seeding proposal for Field 1 and aeration only for Field 3 at a cost not to exceed \$10,275
